RECREATIONAL PIER LEASE

APPLICANTS:

Bill Eastman and Lisa M. Eastman, Trustees of the Eastman Family Revocable Living Trust Declaration dated October 5, 1993
6097 Shiloh Ridge
Santa Rosa, California 95403

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near Carnelian Bay, Placer County.

AUTHORIZED USE:

Continued use and maintenance of a mooring buoy, as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning November 29, 1994.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

Other:

This lease is conditioned on Lessee's obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoy within two years from the effective date of the authorization of the buoy by the Commission.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under






TYPICAL BUOY ANCHORAGE


