**GENERAL LEASE - PROTECTIVE STRUCTURE USE**

**LESSEE:**

Richard Alan Lewis and Wendy Ann Lewis  
70 Geoffroy Lane  
Santa Cruz, CA 95062

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in the Pacific Ocean, near the city of Santa Cruz, Santa Cruz County.

**AUTHORIZED USE:**

Construction and maintenance of a concrete seawall.

**LEASE TERM:**

Ten years, beginning September 1, 1997.

**CONSIDERATION:**

The public health and safety; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

**SPECIFIC LEASE PROVISIONS:**

Combined single limit liability insurance coverage of no less than \$500,000.

**OTHER PERTINENT INFORMATION:**

1. Applicant owns the uplands adjoining the lease premises.
2. On June 6, 1997, the California Coastal Commission (CCC) granted Permit # 3-97-020 for this project under its certified regulatory program (Title 14, California Code of Regulations, section 15251) (c)).
3. Staff has reviewed the document and determined that the conditions, as specified in Title 14, California Code of Regulations, section 15253 (b), have been met for the Commission to use the environmental analysis

document certified by the CCC as a Negative Declaration equivalent in order to comply with the requirements of the CEQA.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

**LAND DESCRIPTION**

A parcel of state owned tide and submerged land situated in Monterey Bay, Santa Cruz County, California, containing rock rip-rap, lying waterward of the ordinary high water mark of the Pacific Ocean and adjacent to Parcel One as described in Exhibit "A" of the deed, Document 75068, to Richard Alan Lewis and Wendy Ann Lewis, recorded October 12, 1993 in Volume 5362, Pages 10 and 11, Official Records of Santa Cruz County. Said parcel is bounded on the southeast by the southerly prolongation of the southeasterly line of said Parcel One, on the northwest by the southerly prolongation of the northwesterly line of said Parcel One, and on the waterward side by the waterward limit of the rock rip-rap authorized by California Coastal Commission Permit No. 3-97-020 and shown on the Topographic Map, Coastal Bluff Stabilization, #70 Geoffrey Drive, prepared November, 1995 by Dunbar and Craig, PLS.


