The regular meeting of the California State Lands Commission was called to order by Member Kathleen Connell at 10:16 a.m., at 1 World Way, Board of Airport Commissioners Meeting Room, Department of Airports Administration Building, Los Angeles, California.

**RECORD OF ACTION TAKEN BY THE  
CALIFORNIA STATE LANDS COMMISSION  
MEETING OF NOVEMBER 7, 1997**

No calendar Items were withdrawn from the agenda prior to the meeting.

The recommendation of the staff, relative to Calendar Items C01- C68, were approved by unanimous vote of Commission Chairman Davis, Commission Member Connell and Commission Member Waddell.

Regarding Calendar Item 69, detailed public comment was heard. At the conclusion of this public comment, the Commission concluded that Mobil's responsibility was to remove the pier and to do so quickly. Commissioner Connell suggested that if an organization comes forward after pier removal with a proposal to improve the surfing conditions at the site, that the Commission's staff should act as an ombudsman for such a project to assist in securing the necessary agency permits and approvals. Commissioner Connell moved and Commissioner Waddell seconded that the staff recommendation be so amended. With this change, the staff recommendation was approved by a vote of 3-0.
