RECREATIONAL PIER LEASE

APPLICANTS:

Arthur E. Engel and Veronica Engel
701 Gage Drive
San Diego, California 92106

AREA, LAND TYPE, AND LOCATION:

Submerged lands in Lake Tahoe, near Carnelian Bay, Placer County.

AUTHORIZED USE:

Modification of pier structures including: removal of boat hoist, installation of boat lift, alterations to boathouse structure, and maintenance of two mooring buoys, as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning January 1, 1998.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

Other:

This lease is conditioned on Lessee's obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years from the effective date of the authorization of the buoys by the Commission.




Tahoe



