1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO TITLE 14, CALIFORNIA CODE OF REGULATION, SECTION 15061 BECAUSE THE ACTIVITY IS NOT A PROJECT AS DEFINED BY PUBLIC RESOURCES CODE SECTION 21065 AND TITLE 14, CALIFORNIA CODE OF REGULATIONS, SECTION 15378.
2. AUTHORIZE STAFF TO ENTER AN AGREEMENT WITH THE LOWEST QUALIFIED BIDDER TO: 1) CONDUCT A FOREST INVENTORY AND PREPARE A FOREST INVENTORY REPORT AND TIMBER TYPE MAP FOR THE SCOTTS CREEK PARCEL; 2) PREPARE A TIMBER SALE AND TIMBER HARVEST PLAN (THP) TO BE SUBMITTED TO THE CALIFORNIA DEPARTMENT OF FORESTRY AND FIRE PREVENTION FOR CERTIFICATION.


SCOTT CREEK HELICOPTER SALE MAP
