RECREATIONAL PIER LEASE

APPLICANT:

Joe M. Cantrell
413 W. Willow Tree Lane
Isleton, California 95641

AREA, LAND TYPE, AND LOCATION:

Tide and submerged lands in Georgiana Slough, near Isleton, Sacramento County.

AUTHORIZED USE:

The continued use and maintenance of an existing 8 foot x 22 foot floating boat dock and a 3 foot x 40 foot walkway.

LEASE TERM:

Ten years, beginning January 1, 1998.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2). Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

2. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
3. The current Lessee, Iris Ferrar, sold the upland and improvements within the lease premises to the applicant. Therefore, the existing lease is being terminated and a new lease issued to the applicant.




