RECREATIONAL PIER LEASE

APPLICANT:

Richard M. Cunha
4111 Garden Highway
Sacramento, California 95834-9600

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Sacramento River, adjacent to the Garden Highway (APN 225-0090-022), near the city of Sacramento, Sacramento County.

AUTHORIZED USE:

An 8 foot x 28 foot floating dock with deflector shield and a 4 foot x 10 foot ramp.

LEASE TERM:

Ten years, beginning August 10, 1998.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance with coverage of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.


