RECREATIONAL PIER LEASE

APPLICANTS:

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near the town of Sunnyside, Placer County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier and three (3) existing mooring buoys, as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning September 1, 1998.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance with coverage of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Applicants are owners of two upland adjoining parcels who share a pier and three (3) mooring buoys.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations,




Lake Tahoe



