RECREATIONAL PIER LEASE

APPLICANT:

Kurt A. Latta, Trustee of the Lattab Trust
Under Instrument Dated March 21, 1990
750 Menlo Avenue, Suite 250
Menlo Park, California 94025

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near Tahoe City, Placer County.

AUTHORIZED USE:

Continued use and maintenance of a pier, boat lift, and two (2) mooring buoys, as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning December 9, 1997.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

Other:

This lease is conditioned on Lessees obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years from the effective date of the authorization of the buoys by the Commission.

2. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.



Lake Tahoe



