GENERAL LEASE - RIGHT-OF-WAY USE

LESSEE:

Century Mendocino Cable Television, Inc.
1060 North State Street
Ukiah, California 95482

AREA, LAND TYPE, AND LOCATION:

0.23 acres, more or less, of sovereign lands in the Albion River, near Albion, Mendocino County.

AUTHORIZED USE:

Continued use and maintenance of an existing television cable, as shown on the attached Exhibit A.

LEASE TERM:

15 years, beginning December 1, 1993.

CONSIDERATION:

\$100 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance with coverage of no less than \$1,000,000.

Bond:

Surety in the amount of \$10,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).



OF A GENERAL LEASE - RIGHT-OF-WAY USE, BEGINNING DECEMBER 1, 1993, FOR A TERM OF 15 YEARS, FOR THE CONTINUED USE AND MAINTENANCE OF AN EXISTING TELEVISION CABLE ON THE LAND SHOWN ON EXHIBIT A, ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; ANNUAL RENT IN THE AMOUNT OF \$100; WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENT PERIODICALLY DURING THE LEASE TERM, AS PROVIDED IN THE LEASE; LIABILITY INSURANCE WITH COVERAGE OF NO LESS THAN \$1,000,000; SURETY IN THE AMOUNT OF \$10,000.


