RECREATIONAL PIER LEASE

APPLICANTS:

Adam Farrow and Karen Farrow
4423 Yacht Harbor Drive
Stockton, California 95204

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Calaveras River, near the city of Stockton, San Joaquin
County.

AUTHORIZED USE:

Partial reconstruction and continued use and maintenance of an existing boat
dock, boathouse and ramp, with the new dimensions being a 4 foot by 44 foot
ramp, a 12 foot by 50 foot main boat dock, a 12 foot by 20 foot side dock, a 14
foot by 35 foot boathouse, and a 6 foot by 8 foot floating ramp support.

LEASE TERM:

Ten years, beginning October 26, 1998.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA
Guidelines (Title 14, California Code of Regulations, section 15061), the
staff has determined that this activity is exempt from the requirements of
the CEQA as a categorically exempt project. The project is exempt under
Class 1, Existing Facilities; Title 2, California Code of Regulations,
section 2905 (a)(2).




AUTHORIZATION:
