Sovereign lands in Huntington Harbour, city of Huntington Beach, Orange
County.

AUTHORIZED USE:

Continued use and maintenance of an existing boat dock, as shown on Exhibit A
attached.

LEASE TERM:

10 years, beginning July 10, 1999.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance with coverage in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:
