291.33 acres, more or less, of lieu lands in the North 1/2 of Section 18, Township  
27 South, Range 28 East, Mount Diablo Meridian, northeast of Bakersfield, Kern  
County.

**AUTHORIZED USE:**

Cattle grazing.

**LEASE TERM:**

Ten years, beginning July 1, 1999.

**CONSIDERATION:**

\$1,165 per year; with the State reserving the right to fix a different rent  
periodically during the lease term, as provided in the lease.

**SPECIFIC LEASE PROVISIONS:**

Insurance:

Combined single limit coverage of no less than \$1,000,000.



# LOCATION MAP


