RECREATIONAL PIER LEASE

APPLICANT:

Charlotte F. Shea, as Trustee of the Charlotte F. Shea Revocable Trust
dated June 18, 1992
5 Elkhorn Place
Suisun City, California 94585

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, Jameson Beach, El Dorado County.

AUTHORIZED USE:

Continued use and maintenance of a pier and one mooring buoy, as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning May 1, 1999.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.



LOCATION MAP



