**GENERAL LEASE - RECREATIONAL AND
PROTECTIVE STRUCTURE USE**

LESSEE:

Darrell L. Johnston and Helen S. Johnston
Trustees under Revocable Trust of Darrell L.
Johnston and Helen S. Johnston dated June 27, 1977
5526 Blossom Terrace Court
San Jose, California 95124

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Sacramento River, near the city of Rio Vista, Solano
County.

AUTHORIZED USE:

An 8 foot by 12 foot floating boat dock and medium-sized quarry stone riprap
bank protection along the shoreline.

LEASE TERM:

Ten years, beginning October 29, 1999.

CONSIDERATION:

The public use and benefit; with the State reserving the right at any time to set a
monetary rent if the Commission finds such action to be in the State's best
interest.

SPECIFIC LEASE PROVISIONS:

Liability Insurance with coverage of no less than \$500,000.

OTHER PERTINENT INFORMATION:

1. Applicant owns the uplands adjoining the lease premises.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905(a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code section 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

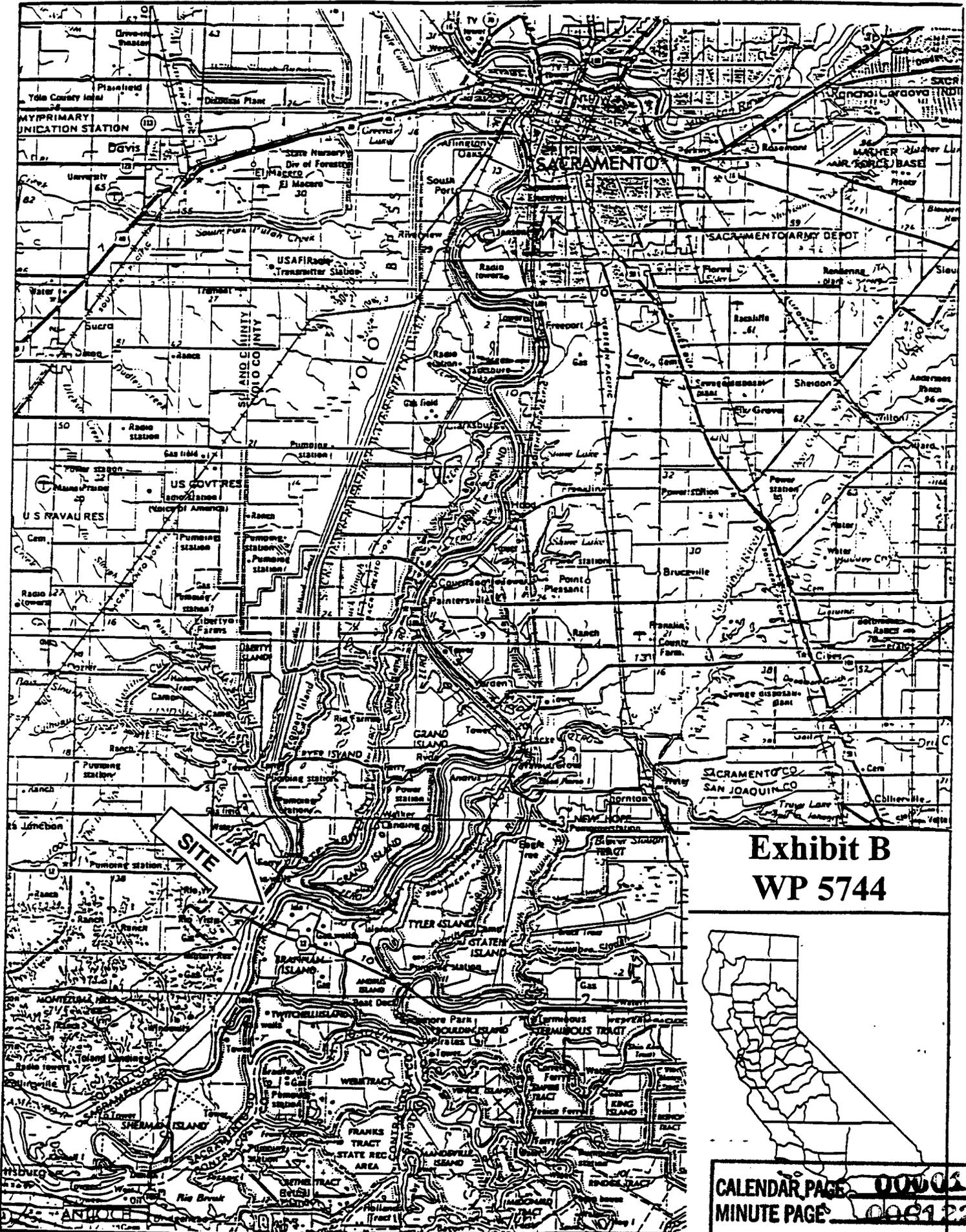
