Sovereign lands in the Sacramento River, Long Island (APN 142-0150-011), near the city of Isleton, Sacramento County.

**AUTHORIZED USE:**

An 8 foot by 24 foot floating boat dock; a 4 foot by 11 foot ramp; and rock riprap along shoreline fronting property.

**LEASE TERM:**

Ten years, beginning June 30, 1998.

**CONSIDERATION:**

Recreational Pier - no monetary consideration pursuant to Public Resources Code section 6503.5.

Bank Protection – the public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

**OTHER PERTINENT INFORMATION:**

1. Assignee owns the uplands adjoining the lease premises.


