**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in Huntington Harbour, near Huntington Beach, Orange County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing boat dock, as shown on Exhibit A attached.

**LEASE TERM:**

Ten years, beginning November 20, 1999.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

**Insurance:**

Liability insurance in the amount of no less than \$300,000.

**OTHER PERTINENT INFORMATION:**



# SITE MAP


