**AUTHORIZED USE:**

Continued use and maintenance of an existing boatshed, enclosed cabana, floating wharf and walkway.

**LEASE TERM:**

Ten years, beginning May 1, 1995.





CO. SUBDIVISION (UNRECORDED)


