GENERAL LEASE-RECREATIONAL USE

LESSEE:

Mercedes See
5636 Lakeville Hwy
Petaluma, CA 94954

AREA, LAND TYPE, AND LOCATION:

0.03 acres, more or less, of sovereign lands in the Petaluma River, near
Lakeville, Sonoma County.

AUTHORIZED USE:

The continued use and maintenance of an existing 5 foot by 26 foot boat dock,
an existing 16 foot by 25 foot deck, and a walkway.

LEASE TERM:

10 years, beginning July 1, 1999.

CONSIDERATION:

\$170 per year; with the State reserving the right to fix a different rent periodically
during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:
\$500,000 Combined Single Limit.
Bond:
\$2,000.

OTHER PERTINENT INFORMATION:

1. Applicant has a right to use the uplands adjoining the lease premises.
2. Applicant does not own the upland; therefore, the lease does not qualify
for rent-free status under Public Resources Code section 6503.5.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.



AUTHORIZE ISSUANCE TO MERCEDES SEE OF A GENERAL LEASE-RECREATIONAL USE, BEGINNING JULY 1, 1999, FOR A TERM OF TEN YEARS, FOR THE CONTINUED USE AND MAINTENANCE OF AN EXISTING 5 FOOT BY 26 FOOT BOAT DOCK, AN EXISTING 16 FOOT BY 25 FOOT DECK, AND A WALKWAY ON THE LAND SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; ANNUAL RENT IN THE AMOUNT OF \$170, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENT PERIODICALLY DURING THE LEASE TERM, AS PROVIDED IN THE LEASE; LIABILITY INSURANCE WITH COVERAGE OF NO LESS THAN \$500,000; SURETY IN THE AMOUNT OF \$2,000.

Ten Foot use area around pier, deck and dock


