**ASSIGNMENT AND AMENDMENT OF LEASE**

**LESSEE/ASSIGNOR:**

Torch Operating Company  
1800 30th Street, Suite 200  
Bakersfield, California 93301

**ASSIGNEE:**

California Gas Gathering, Inc.  
2981 Gold Canal Drive  
Rancho Cordova, California 95670

**AREA, LAND TYPE, AND LOCATION:**

0.0689-acres, more or less, of sovereign lands in the San Joaquin River, near  
Dos Palos, Fresno and Madera Counties.

**AUTHORIZED USE:**

Operation and maintenance of an eight-inch natural gas pipeline.

**LEASE TERM:**

20 years, beginning May 3, 1993.

**CONSIDERATION:**

\$100 per year

**OTHER PERTINENT INFORMATION:**

1. Assignee has a right to use the uplands adjoining the lease premises.
2. Torch Operating Company is the current Lessee of Lease No. PRC 7681.1. Torch became the Lessee pursuant to an assignment and amendment of the lease that was authorized by the Commission on May 9, 1996. Torch now proposes to assign all of its interest in this lease to California Gas Gathering, Inc. The assignment will require Torch to remain liable for obligations under the lease.

CALENDAR ITEM NO. C33 (CONT'D)

3. An amendment of the lease is being proposed to provide for certain modifications to the provisions of the lease addressing operation and inspection of the pipelines. Staff is recommending the lease be amended to provide that the pipeline will be operated in compliance with Title 49 of the Code of Federal Regulations, Part 192 and that duplicate copies of all inspection reports prepared will be provided to Commission staff.
4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by the CEQA and the State CEQA Guidelines.


