**AREA, LAND TYPE, AND LOCATION:**

0.02 acres, more or less, of sovereign lands in Mare Island Strait, near the city of Vallejo, Solano County.

**AUTHORIZED USE:**

Continued use and maintenance of existing recreational and residential structures.

**LEASE TERM:**

20 years, beginning August 1, 1981.

**CONSIDERATION:**

\$105 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

**OTHER PERTINENT INFORMATION:**

1. Assignees own the uplands adjoining the lease premises.



REVISION OF RENT

**LESSEE:**

University of California  
Lawrence Livermore National Laboratory  
P.O. Box 808  
Livermore, California 94550

**AREA, LAND TYPE, AND LOCATION:**

28.80 acres, more or less, of school lands at Los Padres Mine (Section 36, Township 4 North, Range 5 East, SBM), ten miles north of Landers, San Bernardino County.

**AUTHORIZED USE:**

Continued use and maintenance of a seismic detection station.

**LEASE TERM:**

20 years years, beginning July 1, 1994.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$1,300 per year to \$1,434 per year, effective July 1, 2000.

The recommended rent is based on the adjustment of the prior rent by application of the Consumer Price Index (CPI). This adjustment does not obligate the commission to use the CPI to adjust rents other than as specifically set forth herein.


