**CONSIDER ACCEPTANCE OF A QUITCLAIM DEED
AND TERMINATION OF GENERAL LEASE – COMMERCIAL USE**

LESSEE:

Dennis Kawahara and Yolanda Kawahara
11711 Highway 160
Courtland, California 95615

AREA, LAND TYPE, AND LOCATION:

0.12 acres, more or less, of tide and submerged lands in the Sacramento River,
near the town of Courtland, Sacramento County.

AUTHORIZED USE:

A 6 foot by 200 foot guest dock and 12 foot x 84 foot ramp/platform with
connecting gangway, including full disability access and parking.

LEASE TERM:

20 years, beginning June 1, 1998.

CONSIDERATION:

\$325 per year; with the State reserving the right to fix a different rent periodically
during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance with coverage of no less than \$1,000,000.

Bond:

\$5,000.

OTHER PERTINENT INFORMATION:

1. Applicant owns the uplands adjoining the lease premises.

2. In a letter dated June 12, 2000, Lessee informed Commission Staff the guest dock was never built and there are no future plans for construction.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by the CEQA and the State CEQA Guidelines.

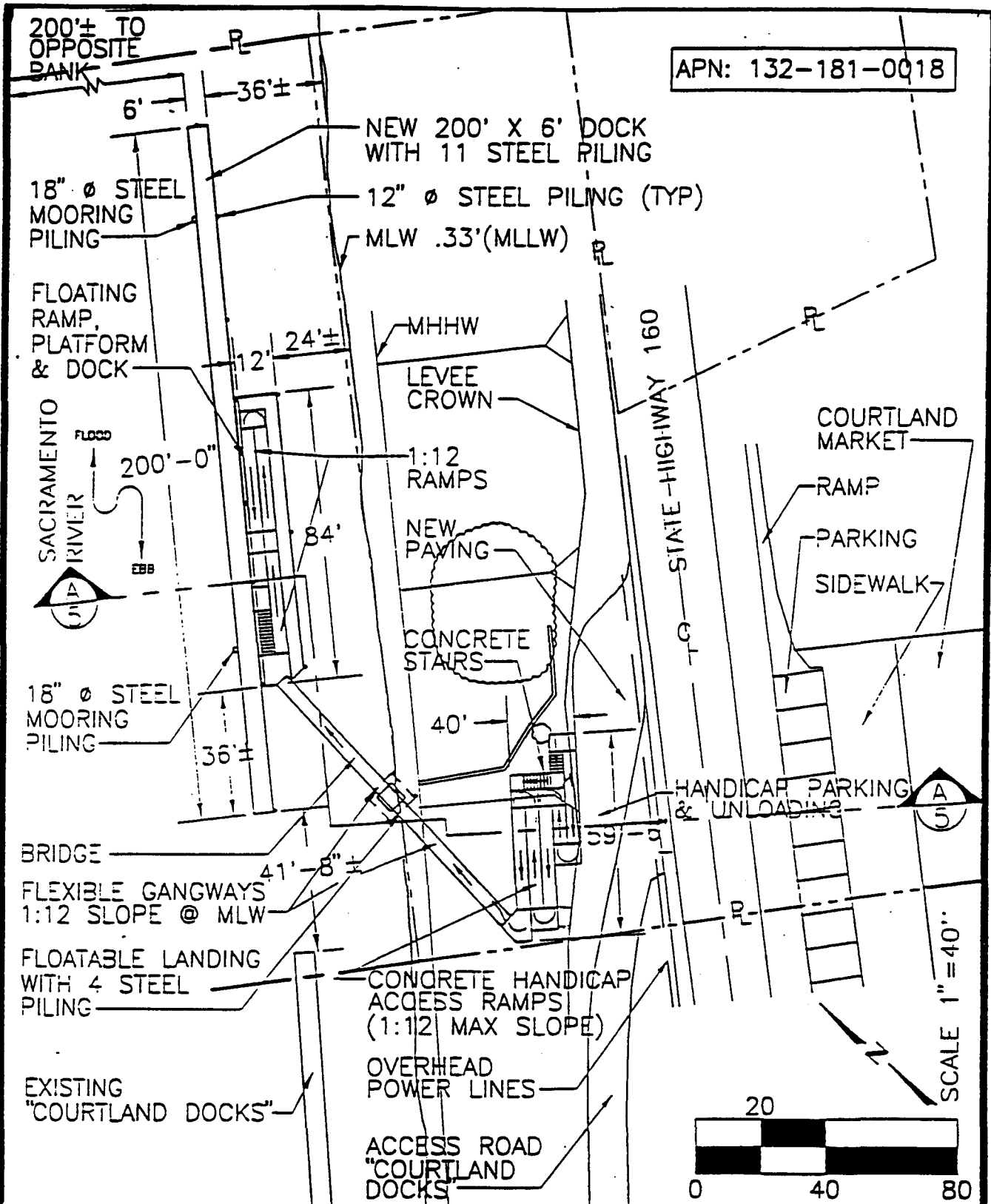

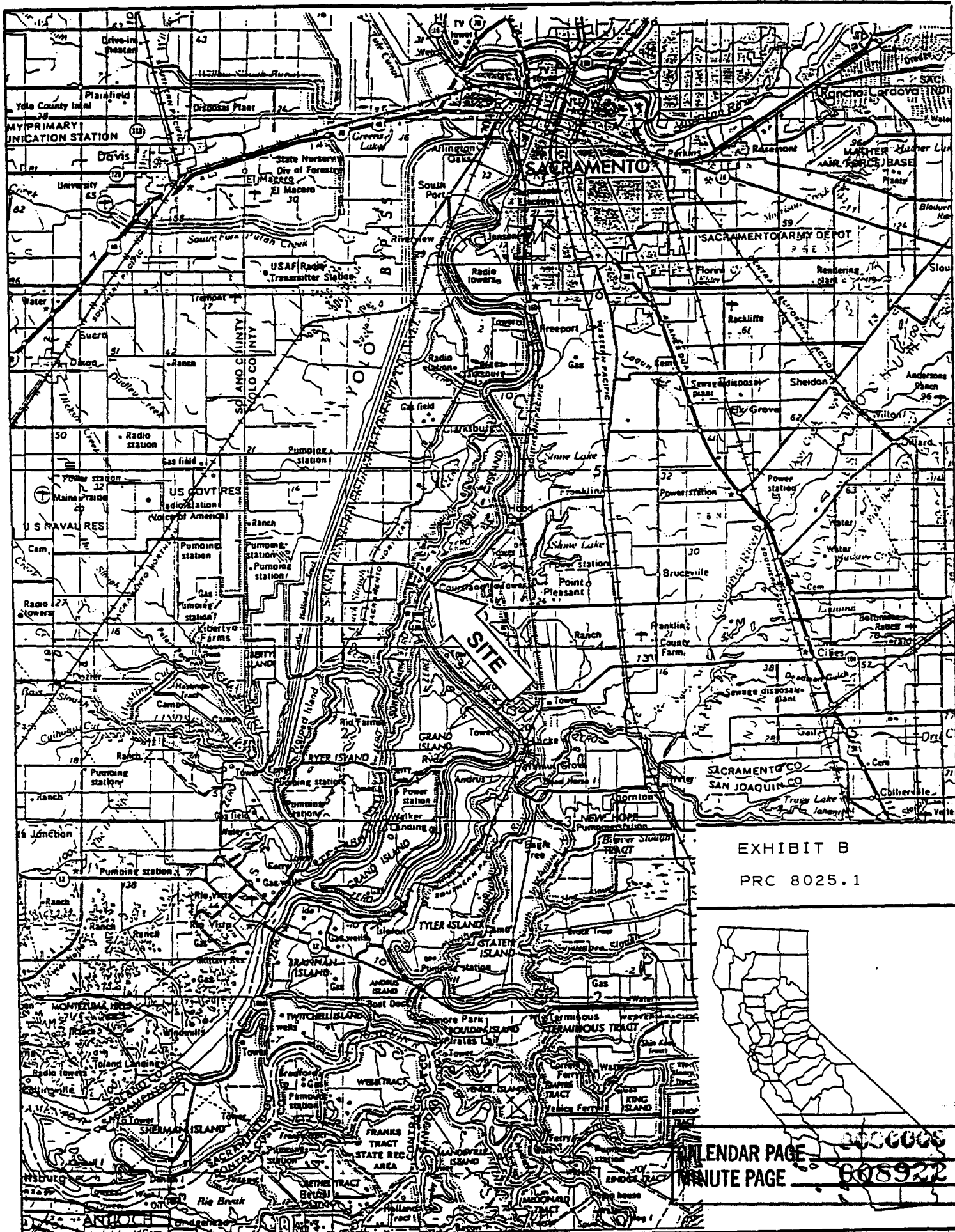
