AREA, LAND TYPE, AND LOCATION:

1.585 acres, more or less, of sovereign lands in Lake Tahoe, near Tahoe Vista,
Placer County.

AUTHORIZED USE:

Operation of a commercial marina as shown on the attached Exhibit A.

LEASE TERM:

Twenty years, beginning June 5, 1985.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease
term. Pursuant to this provision, staff has conducted a review of the rent under
this lease, and recommends that the rent be continued at \$2,200 per year,
effective June 5, 2000.







LOCATION MAP


