**RECREATIONAL PIER LEASE**

**APPLICANTS:**

Richard C. Thomson and Nina T. Thomson  
4625 Garden Highway  
Sacramento, California 95837

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in the Sacramento River, near the city of Sacramento,  
Sacramento County.

**AUTHORIZED USE:**

Reconstruction, use, and maintenance of a 4 foot by 12 foot floating boat dock,  
and a 16 foot gangway subject to the Special Provisions attached as Exhibit B.

**LEASE TERM:**

Ten years, beginning December 16, 2000.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance in the amount of no less than \$300,000.

**OTHER PERTINENT INFORMATION:**

1. On March 6, 1991, the Commission authorized a Recreational Pier Lease with Richard C. Thomson and Nina T. Thomson. That lease will expire on December 15, 2000. The improvements authorized by that lease were destroyed by flood. Applicant is a natural person who has improved the littoral land with, and only uses the upland for, a single-family dwelling. Richard C. Thomson and Nina T. Thomson are now applying for a new Recreational Pier Lease.

CALENDAR ITEM NO. C38 (CONT'D)

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 2, Replacement or Reconstruction; Title 2, California Code of Regulations, section 2905(b).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.





**AUTHORIZATION:**

AUTHORIZE ISSUANCE TO RICHARD C. THOMSON AND NINA T. THOMSON OF A TEN-YEAR RECREATIONAL PIER LEASE, BEGINNING DECEMBER 15, 2000, FOR THE RECONSTRUCTION, USE, AND MAINTENANCE OF A FLOATING BOAT DOCK AND RAMP ON THE LAND SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF TOGETHER WITH SPECIAL PROVISIONS CONTAINED IN EXHIBIT B; NO MONETARY CONSIDERATION PURSUANT TO PUBLIC RESOURCES CODE SECTION 6503.5; LIABILITY INSURANCE IN THE AMOUNT OF NO LESS THAN \$300,000.





**PLAN**

### Special Provisions

1. Lessee is allowed to reconstruct the improvements shown on Exhibit A. Any variation from or additions to the structures indicated on Exhibit A must be approved by Lessor before construction begins.
2. Upon reconstruction of the floating boat dock and gangway, Lessee shall submit post-construction photographs and disclose construction dates.
3. To provide for the State-endangered and Federal- threatened Winter Chinook Salmon, water side or in-water construction activities should only occur between July 1 and September 15.
4. To provide protection for the State-threatened Swainson's Hawk, construction activities should only occur between September 1 and February 28, unless otherwise permitted in writing by the California Department of Fish and Game. (This requirement may be lifted by the California Department of Fish and Game if the project site does not contain a Swainson's Hawk nest and the project activities will not occur within one-half mile of an active nest between March 1 and August 31.)
