#### SUBLEASE/AMENDMENT

#### LESSEE/SUBLESSOR:

### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Cordelia Slough, near city of Fairfield, Solano County.

#### **AUTHORIZED USE:**

PERMIT:

The existing permit presently authorizes the installation, operation, and use of an 11-inch diameter conduit containing twelve (12) innerducts, four of which will each contain one fiber optic cable.

#### TERM:

PERMIT:

Continuous use plus one year beginning April 20, 2000.

#### **CONSIDERATION:**

No monetary consideration shall be charged for the placement, use and maintenance of fiber optic cables or other similar transmission devices placed by those qualifying under the scope of Section 7901 of the Public Utilities Code.

### PROPOSED AMENDMENT:

The proposed amendment (the "Amendment and Consent to Sublease") will authorize Williams Communication Inc. ("Williams") to utilize three (3) innerducts

and three (3) fiber optic cables within the right of way at Cordelia Slough created under PRC No. 8156.9; increase the number of innerducts and cables authorized at the Cordelia Slough crossing from twelve (12) innerducts to a total of fifteen (15) and the number of fiber optic cables from four (4) to a total of seven (7), provide that Level 3 Communications, LLC ("Level 3") and Williams are jointly and severally liable for the performance of all covenants and obligations arising under the Permit; and provide that Williams shall abide by all of the terms, conditions and limitations of the Permit. The proposed amendment will further provide for the lapse of Permittor's authorization for fiber optic cable not installed and placed in service within ten (10) years after authorization. All other terms and conditions of the Permit shall remain in effect without amendment.

#### OTHER PERTINENT INFORMATION:

- 1. At its April 20, 2000, meeting the Commission authorized a Permit for Telephone Right of Way to Level 3 Communications, LLC. The Permit authorized the installation, operation, maintenance and use of a fiber optic cable system underneath nine sovereign waterways. This project serves Level 3's national long-haul network from Sacramento to Los Angeles.
- At its June 27, 2000, meeting the Commission approved Williams
   Communications, Inc.'s, route from Pt. Arena to Sacramento as part of its
   nationwide fiber optic network in California. The above route included a
   crossing at Cordelia Slough. Williams is now seeking the approval of the
   Commission to locate its Cordelia Slough crossing within the right of way
   created under Permit PRC 8156.9.
- 3. Level 3 Communications and Williams Communications entered into a sublease of a portion of Permit PRC 8156.9, dated August 28, 2000. Under the terms of this Sublease, Level 3 will allow Williams Communications to install three innerducts at the Cordelia Slough crossing and each innerduct will contain one fiber optic cable.
- 4. Williams has represented to Permittor that (i) it is a "telephone corporation" within the meaning of Public Utilities Code Section 234, (ii) that the authorized improvements to be located within the right of way ("ROW") applied for herein constitute "telephone line" within the meaning of Section 233 of the Public Utilities Code, (iii) it is authorized to provide intrastate telephone services pursuant to its Certificate of Public Convenience and Necessity ("CPCN"), Decision 99-10-062 issued by the California Public Utilities Commission, (iv) it is authorized to handle

interstate and international telecommunication traffic in accordance with 47 USC § 214, and (v) the authorized improvements will be operated by it as a public utility for the purpose of providing telephone service to the public on a non-discriminatory basis.

5. As to the amendment and consent to sublease, pursuant to the Commission's delegation of authority and State CEQA Guidelines (Title 14, California code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by the CEQA and the State CEQA Guidelines.

Authority: Public Resources Code section 21065 and Title 14, California Code of Regulations, section 15378.

- 6. Level 3 Communications prepared a Mitigated Negative Declaration and was adopted for this project by the CPUC. The California State Lands Commission's staff has reviewed such document. A Mitigation Monitoring Program was adopted by the CPUC.
- 7. Williams Communication prepared a Subsequent Mitigated Negative Declaration for their Pt. Arena to Sacramento route that adopted by the CPUC. The California State Lands Commission staff has reviewed such document. A Mitigation Monitoring Program was adopted by the CPUC.
- 8. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.


