**AREA, LAND TYPE, AND LOCATION:**

2.63 acres, more or less, of sovereign lands in Carquinez Strait, near the city of  
Benicia, Solano County.

**AUTHORIZED USE:**

Continued use and maintenance of three existing underground pipelines  
consisting of two petroleum pipelines (a 6-5/8 inch diameter and a 20-inch  
diameter), and one 16-inch discharge pipeline.

**LEASE TERM:**

30 years, beginning August 21, 1982 (term of existing lease).

**CONSIDERATION:**

\$5,989 per year; with the State reserving the right to fix a different rent  
periodically during the lease term, as provided in the lease under Paragraph 2(b)  
of Section 4 – General Provisions.

**OTHER PERTINENT INFORMATION:**

1. Assignee acquired the uplands adjoining the lease premises, effective  
May 15, 2000.

LAND DESCRIPTION

A parcel of submerged land in Suisun Bay near Benicia, Solano County, California, described as follows:

BEGINNING at a point in Suisun Bay from which the southeast corner of Humble Oil Company Parcel No. 3, as shown on the Record of Survey, Humble Oil Company Properties, Benicia Industrial Park, Benicia, California, which map was recorded December 27, 1966 in Book 10 of Surveys, page 27, Official Records of Solano County, bears N 35° 17' 49" W 3163.74 feet; thence from said POINT OF BEGINNING the following five courses:

1. S 31° 43' 46" W 15.00 feet;
2. S 50° 38' 18" E 160.00 feet;
3. N 39° 21' 42" E 30.00 feet;
4. N 50° 38' 18" W 160.00 feet; and
5. S 31° 43' 46" W 15.00 feet to the point of beginning.

EXHIBIT "A-2"

LAND DESCRIPTION

A strip of tide and submerged land 20 feet wide in Carquinez Strait, approximately 250 feet easterly of the Southern Pacific Railroad bridge between the city of Martinez, Contra Costa County, and the city of Benicia, Solano County, California, said strip lying 10 feet on each side of the following described centerline:

BEGINNING at a point having coordinates of  $x = 1,966,575.23$  and  $y = 134,084.18$  from which point United States Coast & Geodetic Survey triangulation station "Suisun Point 2" bears  $N 38^{\circ} 54' 02'' W 74.62$  feet; thence from said POINT OF BEGINNING  $N 29^{\circ} 05' 28'' W 5379.03$  feet more or less to the intersection with the easterly line of that Legislative Grant to the city of Benicia, Solano County, as described in Chapter 2018, Statutes of 1965, as Amended, said intersection point having coordinates of  $x = 1,963,959.95$  and  $y = 138,784.63$  from which point United States Coast and Geodetic Survey triangulation station "Army Point 2" bears  $N 47^{\circ} 42' 49'' W 1570.05$  feet.

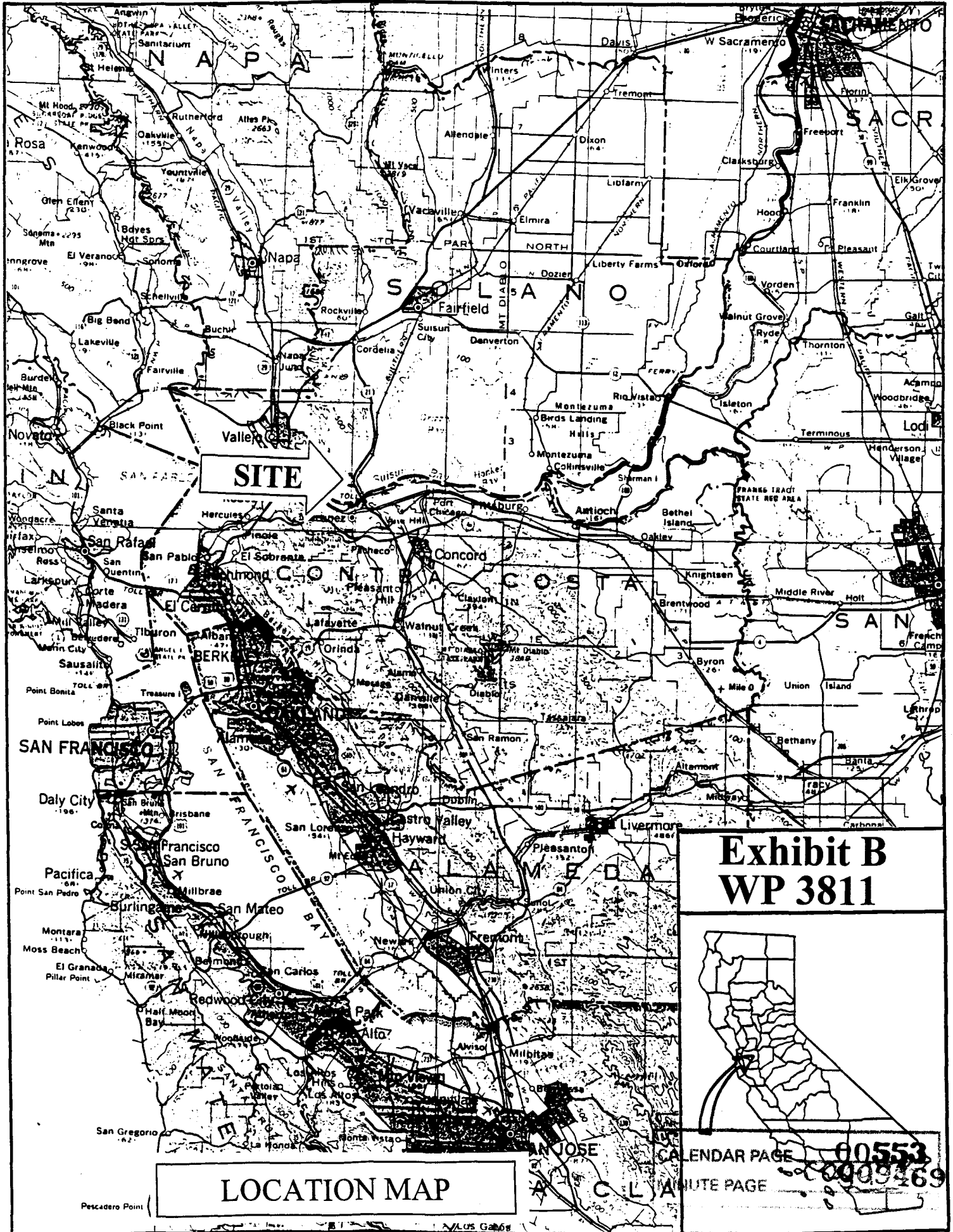
Bearings, distances, and coordinates in the above description are based on the "California Coordinate System, Zone II".

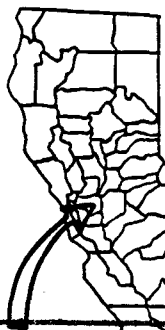
