RECREATIONAL PIER LEASE

APPLICANT:

Raymond M. Snow, Trustee of the Raymond
M. Snow Trust dated December 10, 1991
1398 Hawkins Peak Court
Gardnerville, NV 89410

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Eagle Lake, near Susanville, Lassen County.

AUTHORIZED USE:

Continued use and maintenance of an existing dock as shown on the attached
Exhibit A.

LEASE TERM:

Ten years, beginning September 1, 2000.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance with coverage of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. On June 11, 1990, the Commission authorized a Recreational Pier Lease with Darylne Garrison. That lease expired on June 11, 2000. Darylne Garrison deeded the littoral land to Raymond M. Snow. On December 16, 1991, Raymond M. Snow deeded the littoral land to Raymond M. Snow, Trustee of the Raymond M. Snow Trust dated December 10, 1991. Applicant qualifies for a rent-free Recreational Pier Lease because the Applicant is a natural person who has improved the littoral land with, and uses the upland for, a single-family dwelling. of the Raymond M. Snow Trust dated December 10, 1991, is now applying for a new Recreational Pier Lease.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

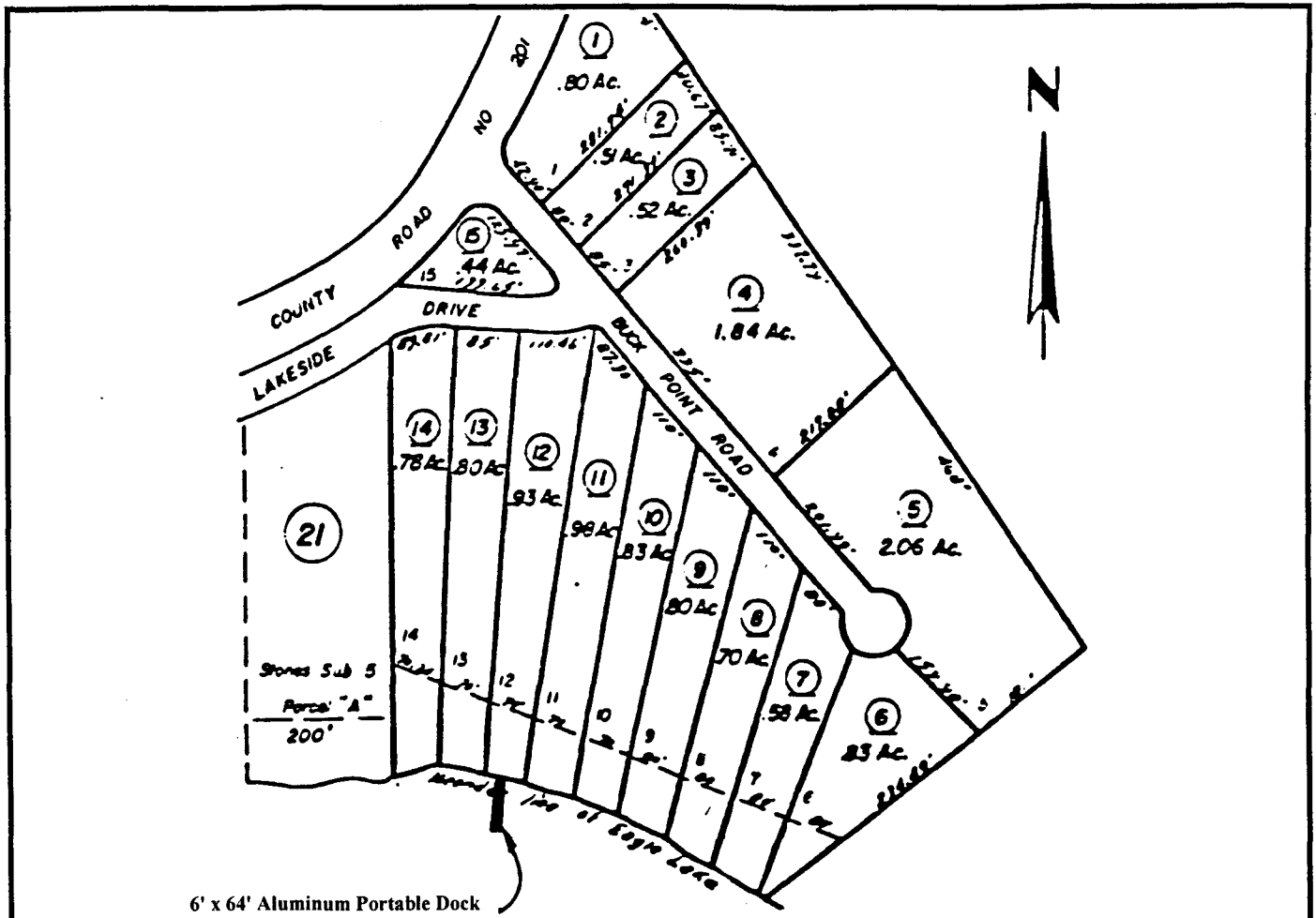

SNOW TRUST DATED DECEMBER 10, 1991, OF A TEN-YEAR RECREATIONAL PIER LEASE, BEGINNING SEPTEMBER 1, 2000, FOR CONTINUED USE AND MAINTENANCE OF AN EXISTING DOCK ON THE LAND SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; NO MONETARY CONSIDERATION PURSUANT TO PUBLIC RESOURCES CODE SECTION 6503.5; LIABILITY INSURANCE WITH COVERAGE OF NO LESS THAN \$300,000.

LOCATION MAP

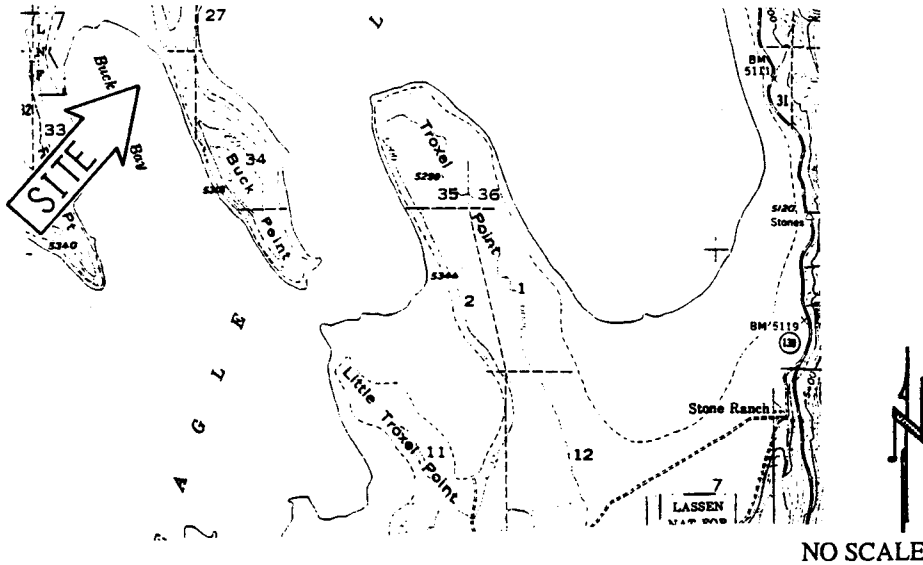
