RECREATIONAL PIER LEASE

APPLICANTS:

Marilyn Belk Wallis and Edward James Wallis, Co-Trustees of the 1996 Jamee Gray Wallis Trust; Marilyn Belk Wallis and Edward James Wallis, Co-Trustees of the 1996 Charlotte Pierce Wallis Trust; Edward James Wallis, Trustee of the Edward James Wallis Trust dated September 26, 1989; and Alan D. Harley and JoAnn W. Harley, Trustees of the Alan D. Harley Trust, initially created April 12, 1995

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near Sunnyside, Placer County.

AUTHORIZED USE:

Continued use and maintenance of a pier, boathouse, boat hoist, and two mooring buoys as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning December 1, 2000.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance with coverage of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. On November 5, 1991, the Commission authorized a Recreational Pier Permit with Ann Milton Wallis Trust. That permit expired on November 4, 1996. On October 23, 1998, the littoral land was deeded to Marilyn Belk Wallis and Edward James Wallis, Co-Trustees of the 1996 Jamee Gray

Wallis Trust; Marilyn Belk Wallis and Edward James Wallis, Co-Trustees of the 1996 Charlotte Pierce Wallis Trust; Edward James Wallis, Trustee of the Edward James Wallis Trust dated September 26, 1989; and Alan D. Harley and JoAnn W. Harley, Trustees of the Alan D. Harley Trust, initially created April 12, 1995. The Applicants qualify for a rent-free Recreational Pier Lease because the Applicants are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. Marilyn Belk Wallis and Edward James Wallis, Co-Trustees of the 1996 Jamee Gray Wallis Trust; Marilyn Belk Wallis and Edward James Wallis, Co-Trustees of the 1996 Charlotte Pierce Wallis Trust; Edward James Wallis, Trustee of the Edward James Wallis Trust dated September 26, 1989; and Alan D. Harley and JoAnn W. Harley, Trustees of the Alan D. Harley Trust, initially created April 12, 1995, are now applying for a new Recreational Pier Lease.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.





