AREA, LAND TYPE, AND LOCATION:

0.30 acres, more or less, of sovereign lands in the Sacramento River, adjacent to

AUTHORIZED USE:

Continued use and maintenance of an existing 350 foot commercial floating
dock.

LEASE TERM:

30 years, beginning July 1, 1982.

CONSIDERATION:

\$865 per year; with the State reserving the right to fix a different rent periodically
during the lease term, as provided in the lease.

OTHER PERTINENT INFORMATION:

1. Assignee owns the uplands adjoining the lease premises.
2. On June 29, 1982, the Commission authorized a General Lease - Commercial Use with Wesley N. Dwyer and Sophia M. Dwyer. In 1987 Sophia Dwyer passed away. On October 17, 1995, the Commission authorized assignment of this lease from Wesley N. Dwyer to Wesley N. Dwyer and June Dwyer. Wesley Dwyer has subsequently passed away and June Dwyer has sold property to Steven Kuhn and Carol Kuhn.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by the CEQA and the State CEQA Guidelines.

LAND DESCRIPTION

WP 5188

A parcel of tide and submerged land in the State-owned bed of the Sacramento River, situated adjacent to and southerly of fractional Section 27, T9N, R4E, MDM, Sacramento County, State of California, more particularly described as follows:

BEGINNING at the southwest corner of Lot 8 of the Natomas Riverside Subdivision No. 1, as called for in Grant Deed recorded in Volume 3709, page 45, Sacramento County records; thence S 29° 47' 40" E 45 feet; thence N 60° 12' 20" E 380 feet; thence N 29° 47' 40" W 45 feet; thence S 60° 12' 20" W 380 feet to the point of beginning.

EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark of the Sacramento River.


