GENERAL LEASE - PUBLIC AGENCY USE

APPLICANT:

Great Basin Air Pollution Control District
157 Short Street
Bishop, California 93514

AREA, LAND TYPE, AND LOCATION:

A parcel of sovereign land located in Protracted Section 5, T18S, R37E, MDM, in
the dry lakebed of Owens Lake, Inyo County.

AUTHORIZED USE:

Ingress and egress utilizing an existing dirt road that crosses State-owned lands
and the construction, use and maintenance of an air monitoring station that will
consist of a 33-foot high aluminum meteorological tower, upper air Radar Wind
Profiler RASS, video recording receiver and shelter and the use and
maintenance of an existing overhead powerline.

LEASE TERM:

Six years, beginning April 24, 2001.

CONSIDERATION:

The public use and benefit; with the State reserving the right at any time to set a
monetary rent if the Commission finds such action to be in the State's best
interest.

SPECIFIC LEASE PROVISIONS:

Snowy Plover Avoidance Measures

OTHER PERTINENT INFORMATION:

1. Applicant has the right to use the uplands adjoining the lease premises.

2. The air monitoring station will become a part of the Applicant's current air monitoring network that is located on and around Owens Lake. Wind speed and direction data collected from the site will be used by the Applicant to construct the wind field in the Owens Lake area during dust storms. The information collected will also be used in conjunction with other meteorological, sand migration, air quality, and air modeling work currently being completed by the Applicant to identify specific dust sources that are contributing or causing ambient air quality violations.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 6, Information Collection; Title 14, California Code of Regulations, section 15306.

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

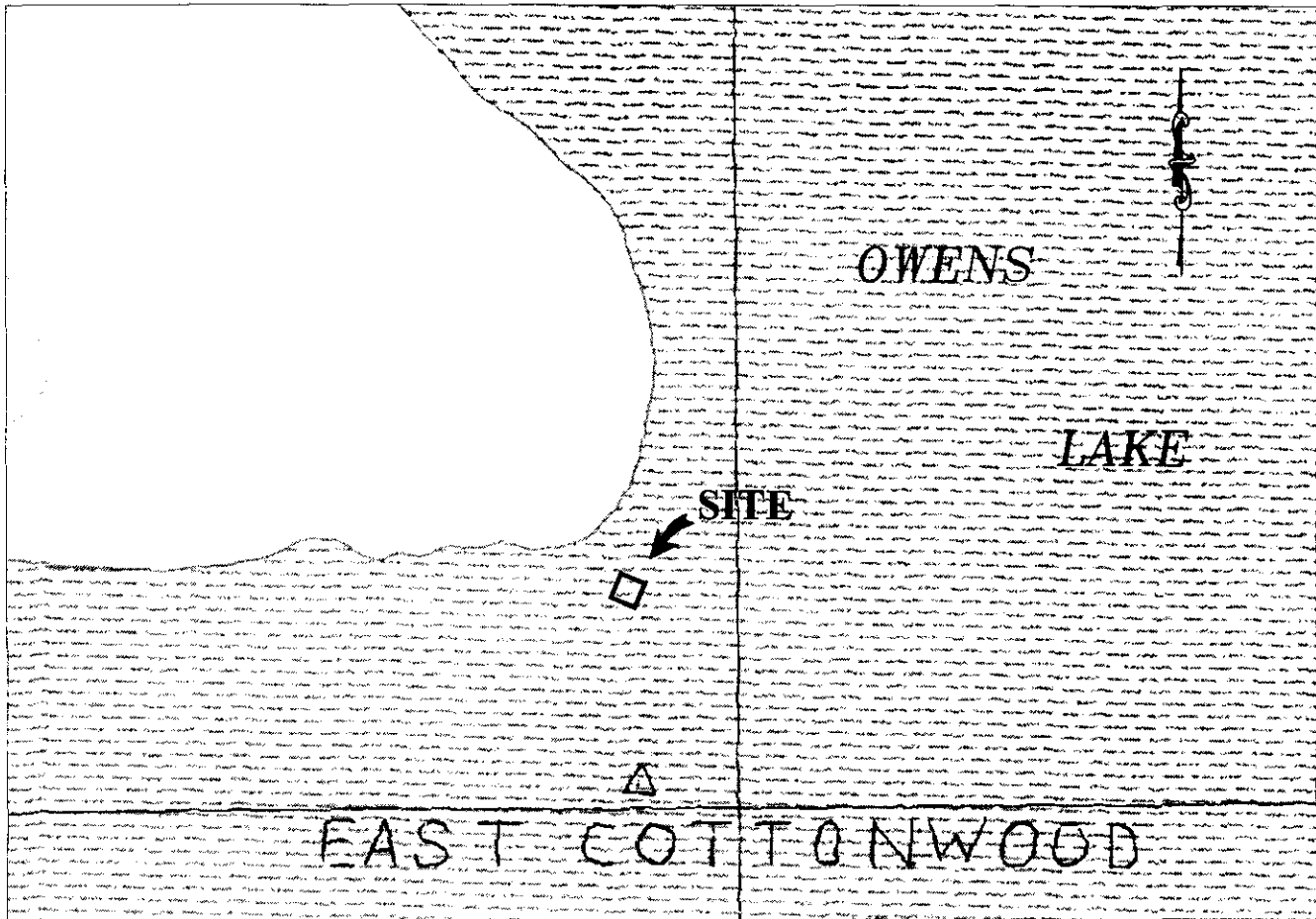

AUTHORIZATION:

AUTHORIZE ISSUANCE TO GREAT BASIN AIR POLLUTION CONTROL DISTRICT OF A GENERAL LEASE - PUBLIC AGENCY USE, BEGINNING APRIL 24, 2001, FOR A TERM OF SIX YEARS, FOR INGRESS AND EGRESS ACROSS STATE-OWNED LANDS AND THE CONSTRUCTION, USE AND MAINTENANCE OF AN AIR MONITORING STATION AND APPURTENANT FACILITIES AND THE USE AND MAINTENANCE OF AN EXISTING OVERHEAD POWERLINE ON THE LAND DESCRIBED ON EXHIBIT B ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; CONSIDERATION OF THE PUBLIC USE AND BENEFIT WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENT IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST.

LOCATION MAP

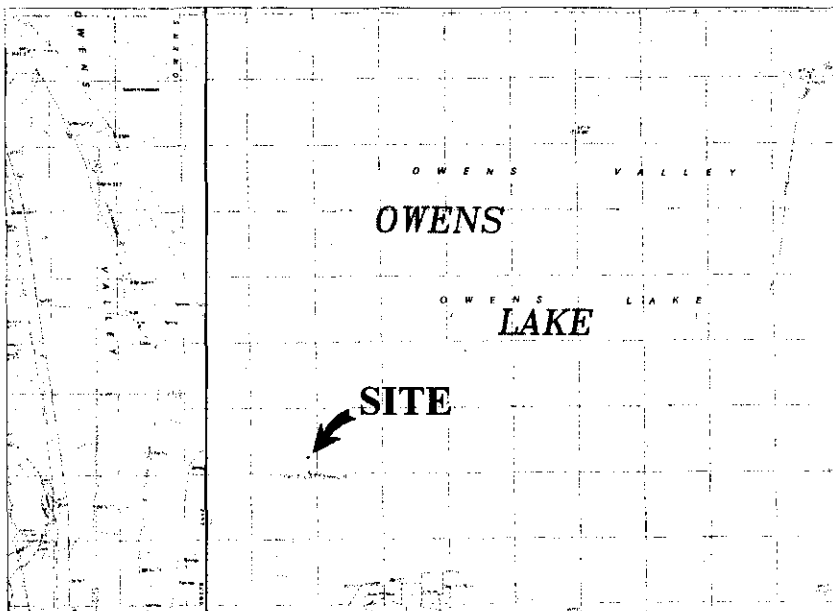

LAND DESCRIPTION

A parcel of land situate in Protracted Section 5, Township 18 South, Range 37 East, M.D.M., Inyo County, California, described as follows:

BEGINNING at a point from which the center of an existing concrete footing measuring approximately 1.5 feet square (the approximate CCS83 Zone 4 coordinates of said center being North y-coordinate=2029319 feet, East x-coordinate=6860732 feet) bears South 22°30'00" West 50.00 feet; thence from said POINT OF BEGINNING South 67°30'00 East 50.00 feet; thence South 22°30'00" West 100.00 feet; thence North 67°30'00 West 100.00 feet; thence North 22°30'00" East 100.00 feet; thence South 67°30'00 East 50.00 feet to the POINT OF BEGINNING.
