REVISION OF RENT

LESSEE:

Torch Operating Company
1221 Lamar, Suite 1600
Houston, TX 77010-3039

AREA, LAND TYPE, AND LOCATION:

5.39 acres, more or less, of sovereign lands in the Pacific Ocean, near Sea Cliff,
Santa Barbara County and Ventura County.

AUTHORIZED USE:

Right of way use for two 12-inch oil and gas pipelines between the Rincon
Operating Facility to offshore Platform "A".

LEASE TERM:

49 years, beginning August 28, 1968.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease
term. Pursuant to this provision, staff has conducted a review of the rent under
this lease, and recommends that the rent be revised from \$23,755 per year to
\$27,612 per year, effective August 28, 2001.

The recommended rent is based on adjustment of the prior rent by application of
the Consumer Price Index (CPI). The adjustment does not obligate the
Commission to use the CPI to adjust future rents.

OTHER PERTINENT INFORMATION:

1. The pipelines are in compliance with Mineral Management Service (MMS)
regulations which require internal inspections every two years. The
results of the last inspection performed on March 28, 2000 were in
compliance with the American Society of Mechanical Engineers (ASME)
code.


