**GENERAL LEASE - RECREATIONAL
AND PROTECTIVE STRUCTURE USE**

LESSEE:

Mr. Thomas A. Treacy
1841 Garden Highway
Sacramento, California 95833

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Sacramento River, near the city of Sacramento,
Sacramento County.

AUTHORIZED USE:

The continued use and maintenance of an existing floating boat dock, walkway
and bank protection.

LEASE TERM:

Ten years, beginning September 19, 2000.

CONSIDERATION:

Floating boat dock and walkway:

No monetary consideration pursuant to Section 6503.5 of the Public
Resources Code.

Bank protection:

The public use and benefit; with the State reserving the right at any time to
set a monetary rent if the Commission finds such action to be in the
State's best interest.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance with coverage of no less than \$500,000.

OTHER PERTINENT INFORMATION:

1. Applicant owns the uplands adjoining the lease premises.
2. The Commission previously authorized a Recreation Pier Permit with Ray W. and Edna Lou Howard. Ray W. Howard, Trustee of the Ray W. Howard Trust UDT dated January 14, 1994, and David Laurence Cole and Donna R. Ruddleston Successor Trustees deeded the littoral land to Thomas A. Treacy. The applicant, Thomas A. Treacy, is a natural person who has improved the littoral land with, and uses the upland for, a single family dwelling, therefor the floating dock and walkway are recreational structures that qualify as rent-free under Section 6503.5 of the Public Resources Code.
3. **Floating Boat Dock and Walkway:**

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

Bank Protection:

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land; Title 2, California Code of Regulations, section 2905 (d)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.


AUTHORIZATION:

LOCATION MAP


