**REVISION OF RENT**

**LESSEE:**

Santa Catalina Island Company  
P. O. Box 737  
Avalon, CA 90704

**AREA, LAND TYPE, AND LOCATION:**

30 acres, more or less, of filled and unfilled tide and submerged lands in the Pacific Ocean, at Jewfish Point and Empire Landing, Santa Catalina Island, Los Angeles. Portions of the leased area acquired by SLC through a title settlement.

**AUTHORIZED USE:**

Continued use and maintenance of existing loading facilities necessary for the support of rock quarry activities. Including mooring of barges during loading activities.

**LEASE TERM:**

49 years, beginning January 1, 1987.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$14,644 per year to \$16,214 per year, effective January 1, 2002.

The recommended rent is based on adjustment of the prior rent by application of the Consumer Price Index (CPI). The adjustment does not obligate the Commission to use the CPI to adjust future rents.


**CEQA FINDING:**
