**GENERAL LEASE**

**LESSEE:**

Orange County CoastKeeper  
441 Old Newport Boulevard, #103  
Newport Beach, California 92663

**AREA, LAND TYPE, AND LOCATION:**

.98 acres (.49 acres at each location), more or less, of sovereign lands in the Pacific Ocean, offshore Malibu and Crystal Cove State Park, Los Angeles and Orange counties.

**AUTHORIZED USE:**

Kelp reforestation, including the outplanting and transplanting of kelp.

**LEASE TERM:**

Five years, beginning April 1, 2002.

**CONSIDERATION:**

The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

Liability insurance with coverage of no less than \$1,000,000.

**OTHER PERTINENT INFORMATION:**

1. Applicants have permission to use an upland mariculture facility.
2. The Applicants are proposing to restore kelp populations, specifically *Macrocystis pyrifera*, in two areas offshore Escondido Beach in Malibu,

Los Angeles County, and within Crystal Cove State Park in Orange County. The sites were selected based on historic kelp levels and potential for survival. The Applicants will gather drift kelp for transplanting purposes. Juvenile kelp plants will be grown at a mariculture facility associated with the Southern California Marine Institute. The plants will be grown until they reach sufficient size to be planted at the restoration sites. Approximately 1500 juvenile kelp plants will be planted at each area. The juvenile kelp will be attached to ceramic tiles with natural-latex (biodegradable) rubber bands. The tiles and rubber bands will be removed as the maturing plants grow and attach themselves to the natural reef structure. In addition to transplanting lab grown kelp, the Applicants propose to relocate fertile kelp (a maximum of 12 transplanted kelp plants per area) in an effort to reduce the grazing pressure from local herbivores on the newly planted juvenile plants.

The Applicants will conduct monitoring for five years and are required to provide an annual report summarizing all project activities and results to appropriate agencies.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA under the general rule that the CEQA applies only to projects which have the potential for causing a significant effect on the environment. The staff believes, based on the information available to it, that there is no possibility that this project may have a significant effect on the environment.

Authority: Title 14, California Code of Regulations, section 15061(b)(3).

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.



