AREA, LAND TYPE, AND LOCATION:

1.42 acres, more or less, of sovereign lands in Huntington Harbour, Huntington Beach, Orange County.

AUTHORIZED USE:

Continued use and maintenance of 60 boat slips, walkways and ramps.

LEASE TERM:

20 years, beginning June 1, 1992.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$12,154 per year, effective June 1, 2002.



5258.1 AT \$12,154 PER YEAR, EFFECTIVE JUNE 1, 2002.


