EXTENSION OF CONSTRUCTION LIMITING DATE

LESSEE:

City of Petaluma
Attn: Mr. Thomas S. Hargis
P. O. Box 61
Petaluma, California 94953-0061

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Petaluma River, in the city of Petaluma, Sonoma County.

AUTHORIZED USE:

Widening and channelization of the Petaluma River in order to relieve frequent flooding of existing streets, homes and businesses in the area; within Payran Reach between Lynch Creek confluence, downstream to just below Lakeville Street.

LEASE TERM:

30 years, beginning April 1, 1996.

CONSIDERATION:

The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

EXTENSION OF CONSTRUCTION COMPLETION DATE:

Staff recommends that the construction completion date be extended from October 31, 2001 to October 31, 2004, due to delay in funding for the U.S. Army Corps of Engineers to complete that project.

OTHER PERTINENT INFORMATION:

The channelization of the river is approximately two-thirds completed at this time with costs estimating \$20 million. An additional \$10.6 million is necessary to complete the project.




EXHIBIT "A"
