**RECREATIONAL PIER LEASE**

**APPLICANT:**

Kim Desenberg and Anna Desenberg, Trustees of the Desenberg Trust dated  
June 22, 2002

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in Tomales Bay, near the city of Inverness, Marin County.

**AUTHORIZED USE:**

Use and maintenance of a portion of the causeway, pier, ramp, and boat dock.

**LEASE TERM:**

Ten years, beginning June 22, 2002.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

Liability insurance in the amount of no less than \$300,000.

**OTHER PERTINENT INFORMATION:**

1. A number of years ago, the previous property owner constructed a causeway, pier, ramp and boat dock without obtaining a Commission lease. The current property owner proposes to bring these facilities under lease and to repair the ramp. Applicant qualifies for a Recreational Pier Lease because the Applicant is a natural person who has improved the littoral land with, and uses the upland for, a single-family dwelling.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of

the CEQA as a categorically exempt project. The project is exempt under Class 2, Replacement or Reconstruction; Title 2, California Code of Regulations, section 2905 (b).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.




