AREA, LAND TYPE, AND LOCATION:

12.48 acres, more or less, of school lands ten miles southeast of Ridgecrest, in San Bernardino County.

AUTHORIZED USE:

10-inch and 12-inch diameter natural gas transmission lines.

LEASE TERM:

25 years, beginning January 1, 1988.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$2,391.40 per year, effective January 1, 2003.

OTHER PERTINENT INFORMATION:

Under United States Bankruptcy Court Case No. 01-30923 DM filed July 29, 2001, the Court approved the Notice of Entry of Order Regarding Motion for Authorization to Settle Post Petition Third Party Claims in the Ordinary Course of Business which authorizes Pacific Gas and Electric Company to continue their operations.


