REVISION OF RENT

LESSEE:

Southern California Edison Company
1851 W. Valencia Blvd., Bldg. F
Fullerton, California 92833

AREA, LAND TYPE, AND LOCATION:

35.24 acres, more or less, of school lands in Sec. 36, T10N, R13E, SBM, San Bernardino County.

AUTHORIZED USE:

Continued use and maintenance of an existing 500 kV overhead transmission line.

LEASE TERM:

49 years, beginning August 28, 1968.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$570 per year to \$650 per year, effective August 28, 2003.

The recommended adjustment of rent is based on adjustment of the prior rent by application of the Consumer Price Index (CPI). Application of the CPI to adjust rents at this time is an interim measure necessitated by budget constraints and resultant losses in staff, and does not obligate the Commission to use the CPI to adjust rents other than as specifically set forth herein.

OTHER PERTINENT INFORMATION:

On August 28, 1968, the Commission authorized a General Lease – Right Of Way Easement to Southern California Edison Company for a term of 49 years.

CALENDAR ITEM NO. C32 (CONT'D)

The easement is for a 500 kV electrical transmission line across 35.24 acres of State school land. Such use of State school lands does not qualify for a rent-free lease. This lease will expire on August 27, 2017.



LOCATION MAP NO SCALE


