**REVISION OF RENT**

**LESSEE:**

Knob Hill Mines, inc.  
dba: Hastings Island Land Company  
1143 Crane Street, Suite 200  
Menlo Park, California 94025

**AREA, LAND TYPE, AND LOCATION:**

1.37 acres, more or less, of tide and submerged lands near Lindsey Slough,  
adjoining Egbert Tract and Lower Hastings Tract, near the town of isleton,  
Solano County.

**AUTHORIZED USE:**

Vehicular traffic bridge.

**LEASE TERM:**

30 years, beginning October 1, 1978.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$225.00 per year to \$268.00 per year, effective October 1, 2003. The recommended adjustment of rent is based on adjustment of the prior rent by application of the Consumer Price Index (CPI).


