**CONSIDER ASSIGNMENT OF A GENERAL LEASE - GRAZING USE  
AND ACCEPTANCE OF A LEASE QUITCLAIM DEED  
AND TERMINATION OF A GENERAL LEASE - GRAZING USE**

**LESSEE/ASSIGNOR:**

Blincoe Farms, Inc.

**ASSIGNOR:**

The Conservation Fund, a Maryland non-profit corporation.

**AREA, LAND TYPE, AND LOCATION:**

23 parcels containing 12,468 acres, more or less, of school lands in northeastern San Bernardino County.

**AUTHORIZED USE:**

Cattle grazing.

**LEASE TERM:**

Ten years, beginning January 1, 2001.

**CONSIDERATION:**

\$1,639 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

**SPECIFIC LEASE PROVISIONS:**

Insurance: Lessee shall maintain limits of no less than: General Liability in the amount of \$1,000,000.

**OTHER PERTINENT INFORMATION:**

1. The California State Lands Commission (CSLC) at its meeting of February 5, 2001, pursuant to Calendar Item 13, authorized the issuance of Lease No. PRC 6840.2 - a General Lease - Grazing Use, to Dave Thornton. At its meeting of June 18, 2002, pursuant to Calendar Item 6, the CSLC authorized the assignment of PRC 6840.2 from Dave Thornton

to Blincoe Farms, Inc. Blincoe Farms, Inc. currently is in escrow to sell the adjoining uplands and upon the close of escrow will no longer have a right to use the uplands adjoining the lease premises. The buyer of the adjoining uplands, The Conservation Fund, a Maryland non-profit corporation (The Conservation Fund) does not wish to pursue grazing on the lease premises and desires to terminate the CSLC grazing lease. However, The Conservation Fund also is acquiring rights to various BLM grazing allotments as part of the purchase from Blincoe Farms. The rights to the BLM grazing allotments are contingent on the acquisition of the CSLC grazing lease. Therefore, Blincoe Farms Inc. and The Conservation Fund have agreed to escrow closing instructions that are contingent upon the assignment of Lease No. PRC 6840.2 from Blincoe Farms, Inc. to The Conservation Fund. Subsequently, The Conservation Fund intends to execute a Lease Quitclaim Deed and Lease Termination for the state lease. The parties have opened an escrow with Nevada Title Company. Escrow is anticipated to close on February 12, 2004.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA Pursuant to the Commission's delegation of authority and the State CEQA Guidelines [Title 14, California Code of Regulations, section 15060(c)(3)], the staff has determined that this activity is not subject to the provisions of the CEQA because it is not a "project" as defined by the CEQA and the State CEQA Guidelines.


