GENERAL LEASE - RECREATIONAL USE

APPLICANT:

Carrion, Ltd.
P.O. Box 1054
Carnelian Bay, CA 96140

AREA, LAND TYPE, AND LOCATION:

0.17 acres, more or less, of sovereign lands in Lake Tahoe, Carnelian Bay, Placer County.

AUTHORIZED USE:

Retention of three existing mooring buoys and placement of three additional mooring buoys for a total of six mooring buoys adjacent to three contiguous littoral parcels as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning January 1, 2004.

CONSIDERATION:

\$558 per annum; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Combined single limit coverage of \$1,000,000.

Other:

This lease is conditioned on Applicant's obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years after the adoption of the Lake Tahoe Shorezone Amendments-Draft Environmental Impact Statement (EIS) and approval of the ordinances based on the EIS.

OTHER PERTINENT INFORMATION:

1. Applicant is the littoral owner of three contiguous littoral parcels, however, Applicant does not qualify for a rent-free lease pursuant to Public Resources Code section 6503.5 because the Applicant is not a natural person. Carrion, Ltd. is now applying for a new General Lease – Recreational Use.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905(c)(3).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.



AUTHORIZATION:

AUTHORIZE ISSUANCE TO CARRION LTD., OF A GENERAL LEASE – RECREATIONAL USE, BEGINNING JANUARY 1, 2004, FOR A TERM OF TEN YEARS FOR THE RETENTION OF THREE EXISTING MOORING BUOYS AND PLACEMENT OF THREE ADDITIONAL MOORING BUOYS FOR A TOTAL OF SIX MOORING BUOYS ON THE LAND SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; CONSIDERATION BEING \$558 PER ANNUM; WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENT PERIODICALLY DURING THE LEASE TERM, AS PROVIDED IN THE LEASE; LIABILITY INSURANCE COMBINED SINGLE LIMIT COVERAGE OF \$1,000,000.

LOCATION MAP



