**CONTINUATION OF RENT**

**LESSEE:**

Emerald Bay Community Association  
600 Emerald Bay  
Laguna Beach, CA 92651

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in the Pacific Ocean, Laguna, Orange County.

**AUTHORIZED USE:**

Continued use and maintenance of seven marker buoys and three swimmer safety lines.

**LEASE TERM:**

Ten years, beginning March 30, 1999.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$515 per year, effective March 30, 2004.

**OTHER PERTINENT INFORMATION**

1. Lessee owns the uplands adjoining the lease premises.
2. On September 3, 1999, the Commission authorized a General Lease – Recreation Use to the Emerald Bay Community Association for a term of ten years. The lease will expire on March 29, 2009. The Commission originally approved the lease of these sovereign lands to the Lessee in 1969. The marker buoys and associated swimmer safety lines are installed and used seasonally beginning May 1st through October 1st.

CALENDAR ITEM NO. C36 (CONT'D)

3. The Emerald Bay Community Association operates as a non-profit corporation that manages a common interest development restricted to its members, guests and tenants. As noted in the Association's by-laws, membership in the Association is restricted to owners of property within the jurisdiction of the Association and is appurtenant to ownership of specific lots comprising the Emerald Bay Community. This is a private gate guarded community. The Lessee owns the three beachfront lots landward of the Lease premises. The lease provides that the Lessee may not exclude the public from recreational use of the lease area.



# LOCATION MAP





Exhibit A
