LESSEE/ASSIGNOR:

Elkhorn Boat Club, Inc.

ASSIGNEE:

Hugh Turner, dba Elkhorn Boat Club, Inc.

Fresno, California 93706

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Sacramento River, near the city of West Sacramento, Yolo County.

AUTHORIZED USE:

Continued use and maintenance of two existing 6.25 foot by 200 foot boat docks, one 6.25 foot by 60 foot boat dock, dolphin and ramp.

LEASE TERM:

15 years, beginning July 1, 2000.

CONSIDERATION:

\$1,160 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

OTHER PERTINENT INFORMATION:

1. Assignee owns the uplands adjoining the lease premises.
2. On February 8, 2000, the Commission authorized a lease to the Elkhorn Boat Club, Inc. for the existing facilities. On June 4, 2003, a Grant Deed was recorded transferring the upland from Elkhorn Boat Club, Inc., to Hugh Turner, dba Elkhorn Boat Club, Inc. Mr. Turner has applied to the

Commission for an assignment of the lease. No improvements to the facility are being proposed.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines [Title 14, California Code of Regulations, section 15060(c)(3)], the staff has determined that this activity is not subject to the provisions of the CEQA because it is not a "project" as defined by the CEQA and the State CEQA Guidelines.




