**RECORD OF ACTION TAKEN BY THE
CALIFORNIA STATE LANDS COMMISSION
MEETING OF APRIL 5, 2004**

Calendar Items C05, C11 and C43 were removed from the agenda to be heard at a subsequent meeting.

The recommendation of staff, relative to Calendar Items C01-C04, C06-C10, C12-C42 and C44-C58 were approved by unanimous vote of Commission Chair Steve Westly, Lt. Governor Cruz Bustamante; and Fred Klass, Commission alternate for Department of Finance.

Lt. Governor Cruz Bustamante left the meeting early, therefore, Lorena Gonzalez, Commission Alternate, voted on items 63 and 64.

Regular Item 59: Commission listened to staff presentation pertaining to the past progress, present status and future schedule for the restoration of the Bolsa Chica wetlands in Orange County. This item was informational item; no action was taken.

Regular Items 60, 61 and 62: Commission listened to staff presentation pertaining to the restoration of the Bolsa Chica wetlands in Orange County. **Item 60** is to grant Fish and Wildlife Service a four-year lease to start construction. **Item 61** is the relocation of the gas line by the City of Long Beach. **Item 62** is to provide CalTrans the right-of-way to build a detour for the Pacific Coast Highway during construction of a bridge and then give ownership of the new bridge. All three items were approved as presented by a 3-0 vote.

Regular Item 63: Executive Officer made a presentation to the Commission on a proclamation in support of Earth Day 2004. The proclamation was approved as presented by a 3-0 vote.

Regular Item 64: Executive officer made a presentation to the Commission pertaining to a letter opposing the development of 36 federal oil and gas leases off the California coast. The Commission approved the letter by a 3-0 vote.
