BACKGROUND:

On October 20, 2003, the Commission approved Calendar/Minute Item C 18, authorizing acceptance of an offer to dedicate (OTD) a public access easement involving land located between the mean high tide line and a rock revetment constructed in 1992 at 31504 Victoria Point Road, Malibu (APN 4470-017-036). The OTD for which acceptance was authorized was recorded on April 7, 1999 as Instrument No. 99-0599297 Official Records of Los Angeles County. However, staff subsequently was informed that the OTD was amended by Instrument No. 99-1511947, recorded in the Official Records of Los Angeles County on August 11, 1999. The amended OTD clarifies and corrects the capacity of the grantor of the OTD as Edward Bridge Danson III, as Trustee of the Bridge Danson Family Trust. No other changes to the OTD were made.
