GENERAL LEASE-RECREATIONAL USE

APPLICANT:

Frank G. Stathos

AREA, LAND TYPE, AND LOCATION:

0.08 acres, more or less, of sovereign lands in the Sacramento River, city of Sacramento, Sacramento County.

AUTHORIZED USE:

Construction, use and maintenance of a new covered boat dock, a gangway and pilings.

LEASE TERM:

Ten years, beginning June 7, 2004.

CONSIDERATION:

\$480.00 per annum; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Combined single limit coverage of no less than \$500,000.

OTHER PERTINENT INFORMATION:

1. The Applicant has the right to use the uplands adjoining the lease premises.
2. The Applicant does not qualify for a rent-free Recreational Pier Lease, pursuant to Section 6503.5 because Applicant is not the littoral landowner.
3. The proposed project involves replacing an existing dock with a new covered boat dock. An existing metal gangway will provide access to the levee berm. This floating boat dock has not been previously authorized by the Commission.

4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905 (c)(1).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.


SACRAMENTO RIVER
