**GENERAL LEASE -  
PROTECTIVE STRUCTURE AND RECREATIONAL USE**

**APPLICANTS:**

Mark D. Leng and Sherri E. Leng

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in the Sacramento River, near the city of Sacramento,  
Sacramento County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing single-berth floating dock,  
gangway, and bank protection.

**LEASE TERM:**

Ten years, beginning October 26, 2002.

**CONSIDERATION:**

Single-berth floating dock and gangway – No monetary consideration pursuant to  
Public Resources Code Section 6503.5.

Bank Protection – The public use and benefit; with the State reserving the right at  
any time to set a monetary rental if the Commission finds such action to be in the  
State's best interest.

**SPECIFIC LEASE PROVISIONS:**

Insurance:

Combined single limit coverage of no less than \$500,000.

**OTHER PERTINENT INFORMATION:**

1. On July 6, 1995, the Commission authorized a General Lease – Protective  
Structure and Recreational Use with Mark D. Leng and Sherri E. Leng.  
That lease expired on October 25, 2002. Mark D. Leng and Sherri E.  
Leng are now applying for a new General Lease – Protective Structure

and Recreational Use. Applicants qualify for a rent free single-berth floating dock, and gangway because applicants are natural persons who have improved the littoral land with, and use the upland, for a single-family dwelling.

2. The bank protection at this location mutually benefits both the public and the applicant. The bank of the river will have the additional protection from wave action provided at no cost to the public.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905(a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.




LENG OF A GENERAL LEASE - PROTECTIVE STRUCTURE AND RECREATIONAL USE, BEGINNING OCTOBER 26, 2002, FOR A TERM OF TEN YEARS, FOR CONTINUED USE AND MAINTENANCE OF AN EXISTING SINGLE-BERTH FLOATING DOCK, GANGWAY, AND BANK PROTECTION AS REPRESENTED ON THE LAND SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; CONSIDERATION: SINGLE-BERTH FLOATING DOCK AND GANGWAY. NO MONETARY CONSIDERATION PURSUANT TO PUBLIC RESOURCES CODE SECTION 6503.5; BANK PROTECTION: THE PUBLIC USE AND BENEFIT; WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; LIABILITY INSURANCE IN THE AMOUNT OF NO LESS THAN \$500,000.


