MEETING OF AUGUST 17, 2004**

Calendar Items C21 and C70 were removed from the agenda to be heard at a subsequent meeting. Calendar items C46 and C62 were moved from consent to the regular calendar.

The recommendation of staff, relative to Calendar Items C01-C20, C22-C45, C47-C61 and C63-C66 were approved by unanimous vote of Commission Chair Steve Westly; Lt. Governor Cruz M. Bustamante; and Dave Harper representing Department of Finance.

**Calendar Item 46:** Commission listened to staff presentation regarding a lease for the restoration of the San Dieguito Wetland Restoration Project. The item was approved as presented by a 3-0 vote.

**Calendar Item 62:** Staff made a presentation to the Commission pertaining to implementation of the Oil Spill Prevention Program. The item was approved as presented by a 3-0 vote.

**Regular Calendar Item 67:** Staff presented report to Commission on oilfield facilities remaining on non-producing offshore leases off Southern California. This was an informational item only; no vote was taken.

**Regular Calendar Item 68:** Commission listened to a staff proposal on adopting a resolution not supporting the California Performance Review's report suggesting abolishing the State Lands Commission. The Commission approved the resolution by a 2-1 vote.

**Regular Calendar Item 69:** The Commissioners listened to a staff presentation and asked for the Commission's support of two measures, H.R. 4900 and H.R. 4706, which would significantly improve the stewardship of our coast and oceans. The item was amended by deleting the 3<sup>rd</sup> staff recommendation and then approved by a 3-0 vote.
