CONTINUATION OF RENT

LESSEE:

Bidart Bros.

AREA, LAND TYPE, AND LOCATION:

200 acres, more or less, of State School Lieu Lands in San Luis Obispo County, near the town of McKittrick, Kern County.

AUTHORIZED USE:

Cattle grazing.

LEASE TERM:

Ten years, beginning February 1, 1999.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$500 per year, effective February 1, 2006.

OTHER PERTINENT INFORMATION:

1. On April 13, 1999, the Commission authorized a General Lease – Grazing Use to Bidart Bros. for a term of ten years. The lease is for cattle grazing on State School Lieu Lands, totaling approximately 200 acres, located near the town of McKittrick. This lease will expire on March 31, 2009.
2. Pursuant to the Commission’s delegation of authority and the State CEQA Guidelines [Title 14, California Code of Regulations, section 15060(c)(3)], the staff has determined that this activity is not subject to the provisions of the CEQA because it is not a “project” as defined by the CEQA and the State CEQA Guidelines.




